

UNRESTRICTED

RESTRICTED

ENDOWMENT

It can also be named after you—or in honor of family, friends, or a major influence in your life, so that they, too, live on for generations to discover. (Minimum investment: \$15,000.)

Two easy estate planning strategies that can benefit you and support DCC students are:

WILLS AND BEQUESTS

The most common bequests are gifts made through a provision in a will or trust. You can make a bequest of a dollar amount, a specific asset, or a percentage of your estate. A key advantage to bequests is that they are made through your estate plan, but can still be adjusted if needed.
